



**Taunton Municipal Lighting Plant  
Off-Peak Charging Program Application**  
*(Allow 8 - 10 week processing time)*



**Program Summary**

Earn an ongoing bill credit of \$10/month. Charge your electric vehicle between 9 p.m. to 9 a.m. weekdays\* & anytime during the weekend, and you'll pay the equivalent of 90 cents a "gallon" for your electric driving.

*\*TMLP reserves the right to adjust the off-peak program hours to accommodate changes in the electric distribution infrastructure.*

**Required Documents & Application Directions**

- (1) Fill out all fields in form. Your application will be returned if any fields are empty.
- (2) Provide a copy of your vehicle's registration. Address on registration must match the TMLP service address associated with the TMLP account number. (Name of vehicle registration doesn't need to match TMLP accountholder's name.)
- (3) Provide picture/screenshot of vehicle's charging schedule, showing active, off-peak timer setting.
- (4) Enter charger information.
- (5) Signatures page 2: If the name on the vehicle registration *matches* the TMLP accountholder of record, sign & date the "Applicant Signature" section. *If the names don't match:* the TMLP accountholder of record must sign the "Permission Signature" section. This allows TMLP's administering agency, ENE to verify account eligibility.

**Program Eligibility**

- (1) Maximum enrollment of two EV's per household.
- (2) Your TMLP residential electric account must be at least 6 months old and have a zero balance (no arrears) on any TMLP account.
- (3) TMLP must be allowed conduct an engineering review and meter upgrade.
- (4) You must own or lease the EV. An EV is defined as either a fully electric battery vehicle (BEV) that runs exclusively on electricity, or a plug-in hybrid electric vehicle (PHEV) that runs on electricity but can switch to gas/electric hybrid mode. No hobby vehicles.
- (5) You may use a Level 1 or Level 2 charger. (TMLP offers a \$300 rebate on Level 2 chargers.)

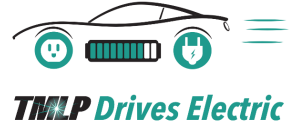
